We've done great things, but 'why' matters most.

With the 2015 fiscal year behind us, we at Family & Children's Place are proud of the achievements accomplished and excited by the prospects of this 2016 fiscal year.

For example, in FY2015 we:

- Opened a new office in Clark County, our second in Southern Indiana, expanding services to help more children and families.
- Held our first ever Building Brighter Futures Breakfast in Southern Indiana.
- Secured reaccreditation for the Kosair Charities Child Advocacy Center, which evaluators declared one of the 10 best in the country.
- Led outreach efforts in April for Child Abuse Prevention Month, with support from our Face It Movement partners.
- Launched our Ambassador program, bringing emerging professionals to the work.
- Added Kentucky Medicaid as a payer source for therapy services, enabling us to serve more struggling children.

Overall, in FY2015, we helped nearly 6,000 children and family members affected by the trauma of abuse, investing thousands of hours of counseling, supervised visitation, forensic interviews and medical exams, after-school activities, helping young people learn how to make positive decisions and stay away from drugs and alcohol, and work with new parents to help them raise the happiest, healthiest babies possible.

We received grants from new and key partners, including Kosair Charities, Gheens Foundation, Metro United Way, Ogle Foundation, and others. It was an amazing and wonderful year and I hope you celebrate, as do I, all we've been able to accomplish.

But I invite you to stay with or join us for the coming very exiting year. We've already expanded our services to new parents and now serve families with more than one child in our HANDS program, immediately adding 100 families to the nearly 600 we already serve.

We were named Nonprofit of the Year and won the Inc.credible Nonprofit Impact Award from Greater Louisville Inc. We've received sizable grants and support from Brown-Forman, Ronald McDonald House Charities, the Honorable Order of Kentucky Colonels, Gheens Foundation, Humana and Kentucky Bar Foundation.

Fiscal Year 2016 is off to a great start, but these all are things we've done, and while worth noting, it's the WHY that really matters.

The "why" is children like Jane, whose life looked bleak not so many years ago. With help from Family & Children's Place, she took control of her life and now, as a young adult, is writing her own future.

Jane, 18, was 10 when she came to us with her mother, who was battling addiction and couldn't provide a safe and secure home for her daughter. Jane recalls the anger, fights and hurt, along with the stress of constantly relocating, as well as her mother's substance abuse.

The trauma led Jane to isolate herself at school and slip into a deep depression. Finally, she found a lifeline to Family & Children's Place. If not for services she received and the relationship the therapist helped her build with her mother, "My life would not be going in the positive direction it is," she says.

Today, she's in college studying to become either a veterinarian or teacher. She still stops by the agency to see friends who helped her heal so she could live – and love – her life again.

Jane is just one of the thousands of the "whys," at Family & Children's Place, all possible due to an incredibly committed and passionate staff and Board, and by support from community service organizations, governments, foundations, grants, businesses and individuals.

Without these teams, working together to ensure happy healthy children and families, freed from abuse, helping us to create a community of caring, there would be no hope and healing for so many, there would be no "why."

OUR SERVICES

Child & Family Services is a broad-based family and individual counseling program serving child and adult victims of violence with proven trauma informed interventions. Without proper assistance, children who experience abuse are more likely to commit crimes, abuse alcohol and drugs, and suffer from depression. Children may suffer lifelong effects without treatment.

HANDS provides voluntary in-home visitation for new and expectant parents that begins during pregnancy or shortly after the child's birth. Our services are proven and effective and help foster healthy pregnancy and births, stable child growth and development, safe homes and self-sufficient families.

The **Kosair Charities Child Advocacy Center** is the region's only facility dedicated to the intervention and treatment of child sexual abuse. The KCCAC brings together the expertise of our staff, police, physicians, Child Protective Services and the Commonwealth's Attorney. Medical exams, forensic interviews and mental health assessments are provided to assure families receive needed services.

Family & School Services are structured school-based programs designed to provide after-school programs to improve academic success and parent engagement. We emphasize character building, learning, social competencies, and the building of a core support team between student, parent, and school.

Family Stabilization Program provides assistance for families and individuals at high risk of homelessness. We help families develop their own plan to become stable, self-sufficient, and remain in safe housing as well as providing crisis intervention.

PAL is a Drug Free Communities Program, funded by the Substance Abuse Mental Health Services Administration, representing the Park Hill, Algonquin, and Old Louisville neighborhoods in Louisville. The program focuses on protective factors that promote resiliency and enhance a young person's ability to resist risks and make good decisions. We believe these youth and community partners can have a profound effect on preventing violence in the lives of children and families.

HAPPY BIRTHDAY, FAMILY & CHILDREN'S PLACE!

September 2015 marked 132 years of continual service to the Louisville community by Family & Children's Place. It's been provided under numerous names but always with one proposition – to give struggling children and families a helping hand up to health, success and happiness.

As times changed, the agency changed. Services and programs were added, adapted and dropped as needed to provide the best continuum of care possible. This stretched from providing coal to keep people warm and food to keep people fed to best in class counseling, treatment and casework for children and families enduring trauma from abuse, neglect, violence, substance abuse, academic and/or economic uncertainties.

It all began in 1883 when the seed that grew into Family & Children's Place, the Charity Organization Society, was planted in Louisville. Tasked with "coordinating existing charity outlets," the agency created a Wayfarer's Lodge for vagrants and a day nursery for children of working mothers – demonstrating early on the compassion and caring the agency is renowned for.



Twenty-four years later, the agency evolved with the times, with a new name, The Associated Charities, and new efforts – continuing to centralize charitable activities, but also creating an "endorsement committee," to investigate and approve charitable organizations and work, establishing its leadership early on in the community service field.

In 1921, the agency morphed into the Family Service Organization (FSO) and helped develop a more comprehensive approach to tackling factors that contributed to social breakdown in families. Along with treatment services, the agency added preventative efforts to better help families and individuals. The FSO also was a charter member in the birth of the Community Chest, which collected money to support community projects, and was a significant contributor to area needs during the Great Depression.

Following the 1931 passage of the Social Security Act, the agency transitioned from relief to providing professional counseling to families and individuals, and by 1940, professional services were the core of the FSO's work. This work continued until 1958, when it merged with The Children's Agency, a child welfare organization created by the merger of The Children's Protective Association and The Children's Bureau.

The Children's Protective Association helped "mistreated children," and oversaw issues such as street begging, parental neglect and cruelty, while the Children's Bureau was the first child-care unit in Kentucky to study foster homes and pay board to foster parents for the care of children. The blended agency also served unwed mothers, provided adoption services and was instrumental in winning passage of legislation to benefit children.

The new nonprofit, Family and Children's Agency now comprised a host of services – counseling for families and individuals, work with older persons, counseling for unmarried mothers, adoption service and foster home placement.

By 1975, the agency absorbed the Travelers Aid Society, which provided social work to vulnerable travelers at train and bus stations and piers, and then in 1990, became the sponsoring organization for Parents United, a program of guided self-help groups, providing support, education and nurturing to those recovering from childhood sexual abuse.

In 1994, the Family and Children's Agency developed a strategic vision, "Project Neighborhood," to offer services through neighborhood centers to provide a continuum of care. Service expansions provided more counseling, including case management and more prevention/education services.

In 1997, following a review of the public's perception of the agency, including awareness and understanding of programs, the board voted to change the name to Family & Children's Counseling Centers. Three years later, the center absorbed Children First, a child advocacy center providing comprehensive support for children who had been sexually abused.

In 2004, to further increase awareness of and support for the work, the board voted again to change the name, to Family & Children First, and then in 2008, a merger between Family & Children First and Family Place, another nonprofit with a similar mission, created what today is Family & Children's Place.

In all, 132 years of supportive, sustaining work – a record we are very proud of, and a commitment we will ever keep – giving Louisville area child victims of abuse, neglect and exploitation and their families a place to go to work through and heal trauma. Daily, we supervise safe parent-child visitations; help at-risk families find safe, secure housing; help new parents raise happy, healthy babies; help at-risk youth make better choices; and help students improve grades and behaviors.

The names have changed, but never the focus – to foster and invest in hope with children and families to build better futures for everyone. We've built a strong foundation, but truth be told, we're just getting started and looking forward to many more years of continued, committed service.

2015 EVENTS

28th Annual Caper

The 28th annual Caper event followed the University of Louisville men's basketball game against Duke University. More than 500 guests sampled food from local restaurants, played some games, took home great auction items, and met former Cardinal Coach and local luminary Denny Crum, along with meeting and getting autographs from Cardinal basketball players.

Child Abuse Prevention Month

In April, Family & Children's Place hosted the annual Rally Against Child Abuse at the Big Four Bridge to commemorate Child Abuse Prevention Month. A large group of community members joined F&CP, Kosair Charities and other members of the Face It Movement to support the call to end Child Abuse. Speakers included Pam Darnall, F&CP president and CEO; Terry Brooks, executive director of Kentucky Youth Advocates; Louisville Metro Police Chief Steve Conrad; Louisville's former chief of community building, Sadiqa Reynolds; and Jerry Ward, Kosair Charities board chair.

Building Brighter Futures Breakfast -- Indiana

Nearly 100 people attended the first ever Building Brighter Futures Breakfast in Southern Indiana, held at the Grand Theater in New Albany, Ind. Guests heard from Gary Thompson, a member of the Family & Children's Place board, president of Imperium Health Management and a survivor of abuse as a child. The agency also awarded a gold medal of appreciation to John Kaiser, Region 18 manager for the Indiana Department of Child Services, for his team's commitment to protecting children and helping families.

Building Brighter Futures Breakfast -- Kentucky

Nearly 400 people attended the annual Building Brighter Futures Breakfast at the Seelbach Hotel in April. Guests heard from Dr. Charlos Thompson, an assistant professor in the College of Arts and Sciences at Kentucky State University, a survivor of abuse as a child and a therapist for Family & Children's Place. The agency also awarded Gold Medals of appreciation to the family of Mary Beth Doheny, a longtime volunteer for the agency; to Barbara and Halsey Sanford for their philanthropy; to the Kosair Charities Face It Movement for advocacy; to the Crimes Against Children Unit of Louisville Metro Police; to the Kosair Charities Division of Pediatric Medicine at the University of Louisville; to the Jefferson County Commonwealth's Attorney Office; and to the Department of Community Based Services. The event raised significant funding in support of our mission.

Golf Scramble

In June, Family & Children's Place held its 12th annual golf scramble at the beautiful Persimmon Ridge Golf Club. Nearly 200 participants hit the links to support agency programs while enjoying food and prizes throughout the day. By day's end, thousands of dollars were raised to support the agency's work.

Other events

Over the past year, Family & Children's Place has been fortunate to be included in a number of third-party events, such as Louisville Uncorked, a wine-tasting event that blended networking and philanthropy, and Beer & Banter with Great Flood Brewing. Lucky's Market also included the agency in its "Bags of Change" campaign. For every reusable bag returned to the market, Lucky's deducted a dime from shoppers' bills, encouraging them to donate that dime to one of three nonprofits, including Family & Children's Place. And The Bard's Town hosted a "Stand Up for Kids" comedy night to benefit the agency.
